## Celebrating the life of a barn—& the beginning of our Heritage Farmstead

It was a beautiful fall day in late October when Board President Sandy Stevenson, recognizing the organization's 5<sup>th</sup> anniversary, announced that the Appalachian Barn Alliance has now officially entered Phase 2 of the mission: to establish a Heritage Farmstead. It was an appropriate setting—county officials gathered with ABA Board Members and the Elaine Ray Thomas and David Thomas family to celebrate their donated barn. The gathering took place in the field where the barn has stood for over 100 years. Elaine and David's daughter Megan Ray Loomis and grandson Caleb Ray Loomis were there as a testament to the importance of the donation to future generations.

There could be no better affirmation of the ABA mission than Elaine Thomas' words during the ceremony. After sharing stories about the life of the barn, she explained why she decided to donate the family barn to the Appalachian Barn Alliance: she "knew without a doubt that Dad would want it to be preserved, and to be used as an educational tool for people to know what we are all about around here, and where we came from. That's what this barn is to me, a testament of where I came from. And so, this is a gift from my Dad, Hughie Ray, and my mother, Lena Ray, to the people of Madison County. People they dearly loved, and that I dearly love. Appalachian Barn Alliance, thank you for taking good care of it for them!"

Although there have been other donations of farm implements and tools over the last year, this marks the first donation of an actual building! The Board Members have begun to take steps to research how to establish a Farmstead. We will be in discussion for awhile determining where it will be and what it will look like (and, of course, raising money to make it happen). But, we are full of pride and excitement that as we take these steps, we have the support of the community that the Farmstead will be representing.

After the short ceremony, volunteers began the work of dismantling the barn, log by log. Ross Young, who is the inspiration for this organization, joined with board members Rob Kraft and Matthew Pierce, spouses of board members (Mike Stevenson and Mike Foster), our researcher Taylor Barnhill, and a loyal member Rick Thomason, and in two days, with the cattle watching, the work was completed. The logs are now stored in another barn awaiting the time when this historic flue-cured tobacco barn can be reconstructed on the new site. In October, we celebrated the "life and memories" of a historic flue-cured tobacco barn donated by a community resident's family (Elaine Ray Thomas & David Thomas). Our membership and donations grew 12% this

past year and I firmly believe when our grant applications are reviewed, the strength of our support base in the community is a huge factor. We received a grant in November making this a record of five years and five grants. Therefore, a huge thank you to all of you for making this a **great** 

year.

#### \$5,000 Grant from Reynolds Foundation

The Reynolds Foundation (formerly the Richard J. Reynolds, III and Marie M. Reynolds Foundation) makes grants for the accomplishment of charitable works, principally in the State of North Carolina. Reynolds who passed away in 1994 was the grandson of the founder of RJ Reynolds Tobacco Company so it seemed a natural to apply for a grant to document the tobacco history of those historic barns in Madison County. The ABA is delighted that they felt our work is a good fit for their mission. This grant will be used to partially fund the documentation in the Marshall township in 2018-the next geographic area Taylor Barnhill will research.
